After the Faerieworlds receives this form- you will be contacted with an acceptance or denial of your application. Vendors will be juried in by the Faerieworlds Committee and then confirmed on a first come, first serve basis. Space is limited.

GENERAL TERMS AND CONDITIONS

1.) Exhibitor agrees to abide by all applicable laws, ordinances and regulations pertaining to health, fire prevention and public safety. Craft Vendors are recommended to have a general commercial liability policy of insurance showing onsite coverage and food vendors are required to have liability insurance and proper health permits.

2.) Exhibitor agrees that all items sold must be listed and described on the attached vendor application. Faerieworlds reserves the right to deny sale of any items not listed on your application.

3.) Exhibitor agrees to set up designated booth before noon on Friday August 1st, 2008 and be open for business by August 1st at 3pm. The Vendor must remain open until 7 pm unless weather dictates an earlier booth breakdown. Vendors will be permitted to start setting up at 10am on Thursday July 31st, and must be broken down and offsite by noon on Monday August 4th.

4.) Exhibitor shall keep the booth area in a clean and sanitary condition at all times. Vendor shall be responsible for removing any and all trash from their booth and surrounding area, and disposing it in the designated recycling or trash container provided on site. Vendor is required to decorate their booth in accordance to the theme of the event. Undecorated plain white 10x10 booths will not be permitted. 5.) Exhibitor agrees to stock sufficient inventory, supplies or commodities to adequately service the anticipated 3,000+ attendees at the festival.

6.) Exhibitor is responsible for providing the entire contents, decorations, costumes and fixtures needed to complete their booth; including but not limited to: Tent (Class 'A' fire retardant FD approved), tables, chairs, display racks, etc.

7.) Exhibitor agrees to indemnify and hold harmless Faerieworlds, its presenters, agents and employees and the Secret House Winery from any and all claims, causes of action suits, damages, theft, injuries and losses to any person or goods arising out of or in any way connected with the renting of space in the festival. Exhibitor agrees that this is intended to be a full and final compromise and release of any claims, demands, causes, actions and causes of actions known or unknown.

9.) Faerieworlds will not be liable for refunds or any other liabilities whatsoever for the disruption of the festival due to reason of enclosure in which the festival is to be produced, being before or during the festival, destroyed by fire or other calamity, or by any Act of God (including but not limited to weather), public enemy, strikes, statutes, or any other cause. Faerieworlds has the option to cancel the festival by May 31 2008 and will return booth fees to exhibitors.

10.) Exhibitor agrees to maintain the dignity and integrity of Faerieworlds and will not perform any acts of a harmful nature. Faerieworlds reserves the sole right to ask any exhibitor or its employees to leave the festival whom they feel are not acting in the best interest of the festival.

11.) Exhibitor understands that upon confirmation and payment, vending booth fees are non-refundable.

12.) Sales or Distribution of the following items will be strictly prohibited: Illegal Substances such as drugs / or drug paraphernalia
Animals / pets • Guns, or other mechanical weaponry • (decorative swords, knives etc, permitted only with prior approval)
No CHILDREN'S SWORDS or WEAPONS, plastic or wooden, whatsoever.

13.) This agreement constitutes the entire contract between the Faerieworlds and the exhibitor. No changes shall be valid unless agreed to by both parties in writing. Should Faerieworlds seek legal action to enforce this contract, exhibitor agrees to pay all fees and costs that the festival incurs, whether or not legal action is instituted. Venue for such action is hereby agreed to be in Lane County.
