After the Faerieworlds LLC receives this form, you will be contacted with an acceptance or denial of your application within four weeks. Vendors will be juried in by the Faerieworlds Committee and then confirmed on a first come, first serve basis. Space is very limited.

GENERAL TERMS AND CONDITIONS

1.) Exhibitor agrees to abide by all applicable laws, ordinances and regulations pertaining to health, fire prevention and public safety of the Lane Events Center and the McDonald Theater. These are posted on the event website. Craft Vendors are recommended to have a general commercial liability policy of insurance showing onsite coverage and food and beverage vendors are required to have liability insurance and proper health permits.

2.) Exhibitor agrees that all items sold must be listed and described on the attached vendor application. Faerieworlds reserves the right to deny the sale of any items not listed on your application.

3.) Event hours are Saturday, January 30 from 10 AM to 6 PM and Sunday, January 31 from 10 AM to 5 PM. Exhibitor agrees to set up designated booth at the Lane Event Center and be ready for business before 9AM on Saturday and be open for business by Saturday at 10AM. Exhibitor must remain open until 5pm. Vendors will be permitted to start setting up at 10AM on Thursday January 28th, and must be broken down and offsite by 10pm on Sunday January 31st.

4.) Exhibitor shall keep the booth area in a clean and sanitary condition at all times. Vendor shall be responsible for removing any and all trash from their booth and surrounding area, and disposing it in the designated recycling or trash container provided on site. Vendor is required to decorate their booth in accordance to the theme of the event. Undecorated plain white 10x10 booths will not be permitted. 5.) Exhibitor agrees to stock sufficient inventory, supplies or commodities to adequately service the attendees at the event.

6.) Exhibitor is responsible for providing the entire contents, decorations, costumes and fixtures needed to complete their booth; including but not limited to: Tent (Class 'A' fire retardant FD approved), tables, chairs, display racks, etc.

7.) Exhibitor agrees to indemnify and hold harmless Faerieworlds LLC, its presenters, agents and employees and Lane Events Center and the McDonald Theatre from any and all claims, causes of action suits, damages, theft, injuries and losses to any person or goods arising out of or in any way connected with the renting of space in the festival. Exhibitor agrees that this is intended to be a full and final compromise and release of any claims, demands, causes, actions and causes of actions known or unknown.

9.) Faerieworlds will not be liable for refunds or any other liabilities whatsoever for any disruption of the festival due to reason of location in which the festival is produced, being before or during the festival, or if destroyed by fire or other calamity, or by any Act of God (including but not limited to weather), public enemy, strikes, statutes, or any other cause. Faerieworlds reserves option to cancel the event by December 1st, 2009 and will return booth fees to exhibitors.

10.) Exhibitor agrees to maintain the integrity, dignity and decorum of the Faerieworlds Winter Celebration and will not perform any acts of a harmful, slanderous, libelous or hostile nature before, during or after the event. Faerieworlds LLC reserves the sole right to ask any exhibitor or its employees to leave the event site if it is determined that they are a threat to our guests of the event itself.

11.) Exhibitor understands that upon confirmation and payment, vending booth fees are non-refundable.

12.) Sales or Distribution of the following items will be strictly prohibited: Illegal Substances such as drugs / or drug paraphernalia animals / pets • guns, or other mechanical weaponry • (decorative swords, knives etc, permitted only with prior approval) No CHILDREN'S SWORDS or WEAPONS, plastic or wooden, whatsoever.

13.) This agreement constitutes the entire contract between Faerieworlds LLC and the exhibitor. No changes shall be valid unless agreed to by both parties in writing. Should Faerieworlds LLC seek legal action to enforce this contract, exhibitor agrees to pay all fees and costs that Faerieworlds LLC incurs, whether or not legal action is instituted. Venue for such action is hereby agreed to be in Lane County, OR.
